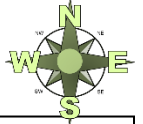

ZONING AUTHORIZATION FAQ'S

FENCES

- ❖ Zoning Authorization Permit is required from the city.
- ❖ Height Requirements:
 - Fence can be up to 4 feet high between the house and the road, and not more than 50% solid.
 - Side yard fence can be up to 6 feet high from the front edge of the dwelling to the rear of the yard.
- ❖ Finished side of fence must face toward the neighboring property.
- ❖ If deemed necessary, the resident desiring to install the fence is responsible for a survey.

ACCESSORY BUILDINGS

- ❖ Zoning Authorization Permit is required from the city.
- ❖ A Building Permit from Clare County is required for accessory buildings over 200 square feet.
- ❖ Location Requirements:
 - Cannot be placed forward of the front edge of the residence; It cannot be placed between the residence and the street.
 - Must have a minimum 6-foot distance away from any other structures on the property; and
 - Must have a minimum 3-foot distance from the property line.

TINY HOMES (Dwellings less than 720 square feet)

- ❖ Must have Planning Commission Site Plan Approval
