A. ORDINANCE 2022-002-PARK RULES

Over the years the City, from time to time, has dealt with complaints of inappropriate and sometimes even criminal behavior at our City Parks and Pettit Campground. City staff have discussed this matter with our City Attorney, and she has provided some recommended ordinance changes that, if adopted, would provide the City a mechanism to deal with such behaviors and deter future incidents of this nature by allowing the city to trespass/ban individuals from the parks system for up to a year at a time if they violate park rules, ordinances, or commit criminal acts. Language has also been added that will allow the City Commission to add/change park rules from time to time as needed without having to amend the actual Code of Ordinances each time.

It should be noted that the Parks and Recreation Advisory Board will be meeting before the Second Reading of the Ordinance amendment to make their official recommendation, but they have already been made aware of the changes and have given informal support to the Recreation Director on the changes proposed.

All ordinance code changes or amendments require the approval of the Clare City Commission. And all ordinances require two readings and approval of the Clare City Commission subsequent to a public hearing. The required public notice announcing the hearing has been published. Subsequent to the conduct of the hearing, the Commission has the option of allowing a First Reading of the proposed Ordinance or denying the conduct of a First Reading, thereby rejecting the proposed ordinance.

The City Commission is asked to conduct the required public hearing, consider and discuss the proposed new ordinance, and direct a First Reading of that proposed Ordinance.

B. <u>UPDATE OF BANKING ACCOUNT SIGNATORIES AND ELECTRONIC</u> <u>BANKING ADMINISTRATION</u>

With the recent hire of new Deputy Treasurer Cheryl Coon, the personnel approved to sign checks and other documents on the City's bank accounts needs to be updated.

A complete review of all of the City's bank accounts has been completed and is summarized for the Commission's review on the attached spreadsheet. The City Commission is asked to approve the list of signatories and designate Deputy City Treasurer Cheryl Coon as a signatory and an Electronic Banking user.

Motion by Commissioner Murphy second by Commissioner Bonham to approve the change of bank signatories and electronic banking administration by adoption of Resolution 2022-085. C. APPROVE BID FOR HOLIDAY DECORATIONS

The City's contract for holiday decoration services expired at the end of 2021, so staff solicited bids for the continuance of these services. The City received only one bid in the amount of \$8,433 which was submitted by Hometown Decoration & Display, LLC.

The DDA reimburses the City for a major portion of the costs for holiday decoration services as the preponderance of the decorations are installed within the DDA District. The proposed contract was reviewed by the DDA at their September 8th meeting. The DDA desires to improve the holiday decoration display this year, thus they have made a recommendation for the approval of the contract in an amount not to exceed \$10K.

Hometown Decoration & Display, LLC is well-known to the City as they have previously performed this service for us and consequently, the City Staff offers its recommendation to award the holiday decorating services contract to Hometown Decoration & Display, LLC.

The City Commission is asked to approve the bid and designate Hometown Decoration & Display, LLC as the vendor to complete this work and authorize the City Treasurer to make any and all budget amendments needed.

Motion by Commissioner Jenkins second by Commissioner Murphy to approve the bid and award the contract in an amount not to exceed \$10K to Hometown Decorations LLC and authorize the Treasurer to make all necessary budget amendments by adoption of Resolution 2022-086. Roll call vote: Yeas: Commissioners Bob Bonham, Pat Humphrey, Maegan Jenkins and Carolyn (Gus) Murphy. Nays: None. Absent: Nick Loomis. *Motion Carried*.

D. <u>APPROVE SOLE SOURCE BID FOR WWTP CONVEYOR SPIRALS AND</u> <u>DRIVE SHAFT</u>

In 2005 (17 years ago), the City bid out and replaced the screenings compactor and conveyor made by Vulcan Industries at the Wastewater Treatment Plant. The spiral conveyors and drive shaft used to separate solids from liquids have now reached the end of their useful life. Dale Clark, Water/Wastewater Superintendent, has requested authority to purchase replacement spirals and drive shaft for the conveyors as a sole source purchase. Vulcan Industries is being recommended for the purchase due to the uniqueness of the conveyor and the fact that it will match the current Vulcan Industries system.

Motion by Commissioner Bonham second by Commissioner Murphy approve the requested sole source purchase request for Wastewater Treatment Plant Conveyor Spirals and Drive Shaft from Vulcan Industries by adoption of Resolution 2022-087. Roll call vote: Yeas: Commissioners Bob Bonham, Pat Humphrey, Maegan Jenkins and Carolyn (Gus) Murphy. Nays: None. Absent: Nick Loomis. *Motion Carried*.

E. <u>MEDC CDBG WRI GRANT-APPROVAL OF ENVIRONMENTAL REVIEW</u> <u>AND SHPO REVIEW CONTRACT</u>

As you remember from earlier this year, the City Commission authorized the submittal of a grant to MEDC for their CDBG WRI grant. Per the requirements of the grant, the city solicited bids for the completion of the required Environmental Assessment and SHPO Section 106 Review as required. Only 2 bids were submitted. Of the two bids, Triterra was the only bidder that was able to submit a bid to complete both the Environmental and SHPO components. I am now asking the City Commission to authorize the selection and contracting of Triterra as the City's selected firm for Environmental Assessment and SHPO Section 106 Review. MEDC has reviewed the bids and has given written approval to enter into contract with Triterra.

10. CITY MANAGER'S REPORT

<u>DDA Meeting</u>. The DDA met on September 8th with one item on their agenda. It was the recommendation to approve the holiday decorations bid that was also on the agenda for the City Commission to approve on September 19th. The recommendation was unanimous and it was also recommended that addition or "nicer" decorations be added to downtown and that the Christmas banners be placed at the roundabout. The board also discussed the status of the wayfinding sings that are being made for downtown. The signs are getting close to completion and will hopefully be arriving soon for installation. I have attached the latest design to this report (48" long with 6" letters). They also discussed and got an update on the downtown camera project and some issues that have come up as MDOT will not allow the placement of the cameras on their poles so other options are being looked into to complete the project.

<u>Planning Commission/Master Plan</u>. The Planning Commission had no business for the September 14th agenda so they were able to cancel their meeting.

<u>MDOT 5th Street (M-115) Project.</u> MDOT is continuing work to resurface 1.2 miles of M-115 from Pioneer Parkway to Sunset Avenue in the city. Work includes sidewalk and improvements to meet ADA compliance. Update: The Contractor is proposing to complete the mill and fill work during the daytime vs night work as was originally planned. This will require some lane closures and detours. The work is anticipated to begin in late September/early October. They will be using flaggers as needed, including around the McEwan/5th St intersection which will have some challenges & cause delays as the milling and paving conveyor are at this intersection, but they are committed to keeping the intersection safe. Also, the ADA ramp replacements have been completed including the installation of cast iron instead of plastic at the corner of 5th and McEwan which should hold up much better to truck traffic and snow plowing.

<u>Street Millage Projects.</u> The work scheduled on Schoolcrest and Beech for ultrathin placement will start on Monday, September 19th.

<u>City Hall Windows</u>. Work on replacing the old windows at City Hall has finally begun as they recently arrived after many weeks on back order. The windows on the north side are nearly complete with the exception of some finish work. The windows look great and DPW is doing a great job replacing them. Work will be moving to the south side of the building with the removal of the aluminum and wood. DPW will soon begin replacement of the windows on the south wall of the building. This will be a welcome update to City Hall aesthetically, it will be much more efficient for heating and cooling, and they will finally keep the rain on the outside of the building.

<u>City Hall Boiler System</u>. Gateway Heating & Cooling have begun installation of the new boiler system. This too will be a welcome addition when installation is complete so that there is a better & more reliable heat source for the first floor of the building this winter.

<u>Lake Shamrock Dredging Project</u>. EGLE's public hearing phase on the 3 sites is still ongoing and we have continued to work with EGLE and our Engineer to move the process forward. EGLE is now requiring further testing of the lake material and that has been collected and sent to the lab for analysis. Results will be given to EGLE for review. We have also begun the process of preparing an RFP for the Dam and Spillway replacement/construction. The hydraulic dredging conversation and likely RFP are also in the works.

<u>Verizon Cell Tower</u>. No new news. We are still eagerly awaiting the arrival of the monopole.

<u>Industrial Park #3</u>. On September 9th the IDC and Steve Letherer were able to facilitate the purchase and closing of the approximately 80 acres from the Russell family. This property was deeded to the city at closing and the IDC will be meeting in the very near future to discuss how to move forward with marketing the property (including the 15 acres contiguous that the city already owns) to potential buyers and also how to seek funds to facilitate the development and infrastructure needed for the new industrial park. This is all exciting news. Thank you again to the Letherer family for helping us make this possible.

<u>Deputy Treasurer Position</u>. We recently hired Cheryl Coon as the new Deputy Treasurer. Cheryl started part time with the city on Wednesday, September 7th. Cheryl was in attendance at tonight's meeting to meet the Commission. Welcome Cheryl!

<u>Addendum: Match on Main.</u> The City recently received their Redevelopment Ready Community (RRC) Essential status which enables DDA businesses to be eligible for Match on Main grant dollars in the amount of \$25K. This is a competitive program where projects compete with other regional projects submitted. Only one or two projects are selected to receive these grant dollars which do require a \$2,500 match.

- 13. <u>COMMISSION DISCUSSION TOPICS</u>: Commissioner Bonham is unhappy with MDOT contractors because they are leaving the sidewalks and streets a mess when the leave for the day, and they continue to block sidewalks with their signage even when they are not working in that area. The DPW Director will contact the MDOT Supervisor regarding these issues to rectify the problem.

For the Agenda of October 3, 2022

<u>Background</u>. A public hearing and a first reading of the proposed Ordinance 2022-002, which includes amendments to our existing ordinance codes, was conducted by the City Commission at the scheduled meeting of September 19, 2022. No public comment was offered or received during the course of the public hearing regarding the proposed Ordinance amendment.

The City Commission is now asked to consider approving Ordinance 2022-002. The Ordinance amendment is attached for final review. Highlights of the proposed amendment are outlined herein:

- <u>Chapter 30, Parks & Recreation</u>. These proposed changes result predominantly from complaints and concerns, and it establishes authority for the City's enforcement agencies to control criminal, inappropriate or publicly disruptive behavior in all city parks; and establishes specific camping rules for Pettit Park.

The Commission now has the option of allowing a Second Reading of the proposed Ordinance 2022-002 or denying the conduct of a Second Reading, thereby rejecting the proposed new ordinance.

The Commission is now asked to allow a Second Reading and either approve or deny the adoption of the proposed Ordinance.

Issues & Questions Specified. Should the City Commission approve Ordinance 2022-002?

<u>Alternatives</u>.

- 1. Approve the proposed ordinance in its entirety.
- 2. Approve the proposed ordinance with aforementioned minor corrections or changes.
- 3. Remove specific elements of the proposed ordinance and approve the remainder.
- 4. Do not approve the proposed ordinance.
- 5. Defer or delay decision on this matter to a subsequently scheduled City Commission meeting.

Financial Impact. There is no immediate fiscal impact related to the proposed ordinance.

<u>*Recommendation.*</u> I recommend the City Commission allow a Second Reading and approve proposed Ordinance 2022-002 by adoption of Resolution 2022-090.

ORDINANCE NO. 2022 - ***

AN ORDINANCE TO AMEND THE CODE OF THE CITY OF CLARE BY amending the City Code, Chapter 30.

Short Title: CITY OF CLARE - ORDINANCE AMENDMENT

Chapter 30, Article III, Section 30-75, of the Clare City Code is hereby revoked and restated as follows:

Sec. 30-75. - Camping in Pettit Park.

It shall be unlawful to do any of the following upon city park lands:

- (1) *Designated camping areas.* Camp in any city park on city owned lands without written permission. Pettit Park is a state licensed campground and camping is permitted only in a designated number of campsites.
- (2) *Camping fees.* Camping without having paid the camping fee on the date of stay and for each day of stay is hereby designated as unlawful.
- (3) *Visitors.* Be in Pettit Park after curfew 11:00 p.m. to 6:00 a.m. without a proper receipt of payment for camping.
- (4) *Registration.* Each camper shall properly register for each night's camping in accordance with the City procedures then established.
- (5) *Quiet hours.* Between the hours of 11:00 p.m. to 6:00 a.m. it shall be unlawful for persons who are not registered campground users to be in the campground or day use area.
- (6) It shall be unlawful for individuals to wash dishes at the water pumps or water supply.
- (7) It shall be unlawful for park users to fail to clean up their camp site daily.
- (8) It shall be unlawful for camp users to discharge waste of any type except into designated containers or the dump station.
- (9) It shall be unlawful for unsupervised children to occupy a campsite. Supervision must be provided by a parent or legal guardian eighteen years of age or older.
- (10) It shall be unlawful for a person to occupy the campground as a permanent or semi-permanent residence or to operate a business from the premises.
- (11) Pets. Possess any animal considered a pet, unless such pet is on a leash no longer than six feet, or allow a pet to disturb or annoy other park users, or fail to clean all scat and other messes created by a pet in such person's possession. Running a pet for the purpose of relieving itself is unlawful,

except in designated pet runs. It shall be unlawful for pet owners to relinquish control and supervision of their pet(s) at all times,

- (12) The City Commission may adopt additional rules and regulations, as required from time to time, without the necessity of amending this ordinance.
- (13) The delegated authority of the City Commission, being the City Manager, and/or Parks and Recreation Department Head, and/or the City Police Chief, in their sole discretion, may issue any individual(s) a trespass (for involvement in any park rule violation, ordinance violation, or criminal law violation), for a period of up to one year at a time, prohibiting that individual from entering any City Park. Upon violation of any ban so issued, the individual shall be guilty of trespass.

RESOLUTION 2022-090

A RESOLUTION OF THE CLARE CITY COMMISSION APPROVING ORDINANCE AMENDMENT 2022-002, CHAPTER 30, PARK RULES.

WHEREAS, the Clare City Staff, City Attorney, and the Parks and Recreation Advisory Board have recommended a change to the exiting Park Rules Ordinance of the City of Clare; and

For the Agenda of October 3, 2022

<u>Background</u>. Chapter 4, Section 4.10 of the City Charter (att'd) provides that the compensation of election personnel shall be determined in advance of an election by the City Commission. The City's last election inspector wage rate increase occurred in July 2018. At that time the election chair's wage was approved at \$14.00 per hour; \$12.00 per hour for the precinct vice chairperson; and \$11.00 per hour for all other election inspectors

Election Chairpersons are responsible for oversight of the AVCB & polling locations; the accuracy of election results; the completeness of paperwork; to safeguard voting materials; to maintain the order and security of elections; to protect the integrity of elections; and they are typically required to work a minimum 16-hour day (or longer if necessary). The Election Vice Chair is required to fulfill the duties of the Election Chair at the polls during their absence for breaks, lunch, or assisting with the needs of voters. All election personnel are required to assist in setup of the polling location the day before the election, assist voters on election day, and contend with election issues as required under State and Federal law.

Today's elections have become more technologically complex and election security requirements have increased. The education requirements for election inspectors have been amplified over the years and there are continued and expanding health and safety risks, thus, I am proposing the following wage increase for election inspectors: Election Chair, \$15.00 per hour; Vice Chair, \$13.00 per hour; Election Inspector, \$12.00 per hour.

In order to retain qualified and knowledgeable inspectors in the City and attract new inspectors it is important that we offer competitive wages. The City's Election Commission will meet at 9:00 am on October 3, 2022 to consider the proposed wage increase and provide a recommendation to the City Commission.

<u>Issues & Questions Specified</u>. Should the City Commission approve the new wage scale for the election inspectors?

<u>Alternatives</u>.

- 1. Approve the new wage scale.
- 2. Approve the wage scale with modifications.
- 3. Do not approve the wage scale.
- 4. Table the matter for further consideration and/or deliberation.

Financial Impact. Less than \$300.00 for the November 8, 2022 General Election. Funds are available and have been budgeted to support the revised wage scale.

<u>*Recommendation.*</u> I recommend that the City Commission approve the new wage scale for election inspectors by adoption of Resolution 2022-091.

Section 4.10. Election commission.

An election commission is hereby created, consisting of the clerk, the mayor, and the city attorney. The clerk shall be chairman. The compensation of election personnel shall be determined in advance by the city commission. In any case where election procedure is in doubt, the election commission shall prescribe the procedure to be followed.

<u>MDOT 5th Street (M-115) Project.</u> MDOT is continuing work to resurface 1.2 miles of M-115 from <u>Pioneer</u> <u>Parkway to Sunset Avenue</u> (click for map), in the city of Clare. Update: Lane closures using flagman are currently underway. They did get a late start considering it was a Monday, September 26th start time originally. They are doing the joint repairs at the moment from the tracks heading west. They are currently working in the 300 block and should be in the 100 and 200 block of W. 5th by September 30th and will detour traffic down Maple to 4th St.

<u>Public Land Sale.</u> Recently the City received a letter from the Clare County Treasurer notifying us that 2 parcels of land, now owned by the County, are going up for bid that are contiguous to our property along Brookwood Drive. The parcels are similar to the property we currently own by Pettit Park along the river. I am including the information in case the City Commission desires to bid on the land to try and acquire it. The two parcels combined are less than .5 acres. It would be my recommendation that we do not try and acquire the land and that it will hopefully be bought by someone who will allow the parcels to be put back on the tax roll and generate tax revenue. However, if you disagree and would like staff to pursue placing a bid, we can certainly do that if that is the desire of the City Commission.

<u>Clare Family Night Out.</u> Family Night Out is on October 4th! There will be lots of fun activities, cool prizes, great food, and much more! This is a FREE family event so bring the whole family out to Clare on October 4th! There will be many participating businesses around town and under the tents in the Wood's Household parking lot that will have lots of fun games, prizes, food, activities, and much more! A full schedule of events and participants for this fun event are attached in the flyer below.

<u>Sister City – Clare, England.</u> Recently the City was contacted by Marty Johnson with the Clare County Historical Society with a proposal to start a Sister City relationship with Clare, England.

Clare England's History: Early in WWII, the US Navy sent the British Navy 50 old destroyers to retrofit and use against the Germans. The British renamed the ships for cities in both countries that shared common names. One ship, the USS Upshur, was renamed the HMS Clare. After the war, a delegation from the Royal Navy visited our city and presented us with items from the ship. The badge from the ship is across the street in City Park (picture attached). A ship's log they gave us has since disappeared and sadly, no one knows where it's gone.). Mr. Johnson is proposing an "informal" sister city arrangement and mostly it would allow a High School class from each city to connect and do most of the work allowing them to gain experience in municipal government workings as well as develop relationships with and learn more about their peers in Clare, England.

Below is some additional information and a proposal from Mr. Johnson on how the sister city relationship might work.

I contacted Emma Harrington, a teacher at Clare Michigan High School. She's excited and wants to have her 12th-grade history class take it on. As to next steps, here's what I will suggest:

- 1) I will work with Ms. Harrington to contact a school in Clare, England to see if a class there wants to work with their city to make us a Sister City. If not, we can work directly with their mayor.
- 2) Students of Ms. Harrington will address our City Council to ask if we'd be willing to recognize Clare, England as a Sister City. They would provide their reasons.
- 3) Both cities create a Proclamation recognizing the relationship. There's a draft template available that we/you/I can customize.
- 4) The students send the Proclamation to England. Clare, England sends its Proclamation to our students. Maybe we include a local history book on Clare or something with our logo in our mailing. Maybe Pat or Jeremy can FaceTime with Clare, England students if they want it.
- 5) Our students attend a City Council and present the English Proclamation to our city. Media is invited. At the same time, the city shows off two roadside signs (for north & south of town) that will be installed now that the relationship is formalized.
- 6) Life goes on as usual.

The above are just my initial ideas. I'd be happy to sit down with anyone from the city, perhaps with Ms. Harrington. Please let me know of any concerns or ideas.



This letter is in response to your Public Records Request dated September 15, 2022. Your request to review, without touching, all tabulated ballots from the November 3, 2020 Election for the City of Clare, Michigan is hereby granted.

Pursuant to MCL 15.234 and the City of Clare's FOIA policy, a public body may charge a fee for labor associated with fulfilling a Freedom of Information Act request when failure to do so will result in unreasonably high costs to the public body that are excessive and beyond the normal or usual amount for those services compared to the public body's usual FOIA requests. Because only a Clerk or another person deputized and authorized by a Clerk may legally handle election records, it will be necessary for me or one of my staff to assist you in your inspection of the ballots.

The Freedom of Information Act requires that the amount charged be equal to the salary of the lowest paid employee capable of doing the work plus up to 50% of benefits. In this case, that is \$22.00 per hour. To process your request, the City of Clare estimates a FOIA processing fee of **\$192.10** to search for, retrieve, review, separate and examine material, and be present and assisting during your inspection of the requested records. 



People are instinctively driven to fulfill their basic needs such as hunger and thirst, but our needs go beyond that. Everyone, including your residents, are driven to be connected to others, feel safe, and have predictability and influence. A community with a well being orientation focuses on supporting access to well being throughout systems.






