Background. Firefighter Marvin Farley has faithfully served the residents of the City of Clare as a member of the Clare Fire Department for the past 30 years. The City Commission is asked to formally recognize Marv for his exemplary, faithful, courageous, and dedicated public service.

Issues & Questions Specified. Should the City Commission formally recognize Firefighter Marvin Farley for his exemplary public service?

Alternatives.

1. Formally recognize Firefighter Farley.
2. Do not recognize Firefighter Farley's exemplary public service.
3. Set aside a decision regarding this matter to a later date.

Financial Impact. The cost to the City is \$150 (\$125 longevity stipend and the cost of a framed resolution).
