Background. Tom Francisco has completed 10 years of faithful, dedicated service to the City of Clare as a member of the City's Police Department. We ask that the City Commission recognize Tom for his extraordinarily outstanding service.

Issues & Questions Specified. Should the City Commission formally recognize Tom Francisco for 10 years of faithful, dedicated public service?

Alternatives.

2. Do not recognize Tom Francisco for his service.
3. Set aside the matter for further discussion and consideration at a subsequently scheduled public meeting.

Financial Impact. The fiscal impact to the City is approximately \$50 (\$25 stipend and \$25 for a framed resolution).

Recommendations. I recommend that the City Commission recognize and honor Tom Francisco by adoption of Resolution 2023-015 (copy *att'd*).
