Background. A request was received recently to make East 7th Street and Pine Street a four way stop for increased safety of pedestrian traffic. The Traffic Safety Committee met on July 11, 2023 and discussed the area which includes a Methodist church, two Day Cares and has seen increased traffic in recent years. The area was noted to be of particular concern due to pedestrian traffic during school hours. It is believed the additional stop signs making this a four-way stop will increase safety of pedestrians and other motorists. The City's Traffic & Safety Committee has reviewed the request and recommended approval of the request (*see att'd minutes*). The City Commission is asked to approve the request by issuance of a Traffic Control Order 001-2023 (*att'd*).
