Background. The BRA has recommended that the current appointments of Greg Rynearson and Gus Murphy be renewed for another term; the City Commission is asked to renew the appointments.

Issues & Questions. Should the City Commission renew the terms of Greg Rynearson and Gus Murphy to serve another term as voting members of the BRA?

Alternatives.

1. Approve the two re-appointments.
2. Do not make the recommended re-appointments.
3. Set the decision aside to a subsequently scheduled public meeting.

Recommendation. I recommend that the City Commission approve the reappointments of Greg Rynearson and Gus Murphy to serve as voting members of the Clare BRA by adoption of Resolution 2023-089 (*copy att'd*).

RESOLUTION 2023-089

A RESOLUTION OF THE CLARE CITY COMMISSION RENEWING THE APPOINTMENTS OF MR. GREG RYNEARSON AND MS. GUS MURPHY TO CONTINUE SERVING AS VOTING MEMBERS OF THE CITY OF CLARE BROWNFIELD REDEVELOPMENT AUTHORITY.

WHEREAS, the Clare Brownfield Redevelopment Authority has petitioned the Clare City Commission to renew the appointments of Mr. Greg Ryneerson and Ms. Gus Murphy as voting members of the City of Clare Brownfield Redevelopment Authority; and

WHEREAS, said individuals have expressed their willingness to continue serving in said position; and

WHEREAS, the City Commission has determined that said individuals remain fully qualified to assume the duties and responsibilities of said position.

NOW THEREFORE BE IT RESOLVED THAT the Clare City Commission hereby renews the appointments of Mr. Greg Ryneerson and Ms. Gus Murphy to serve as voting members of the Clare Brownfield Redevelopment Authority, said appointments being effective this date and shall terminate not later than the 5th day of November 2026, unless said individuals offer their resignation to the Chairman of the Clare Brownfield Redevelopment Authority or the Brownfield Redevelopment Authority or the Clare City Commission takes specific action to terminate said appointments prior to said date.

BE IT FURTHER RESOLVED THAT said appointments are voluntary and without compensation and can be terminated at the will of the Chairman of the Clare BRA or the Mayor of the City of Clare with or without cause.
