RE: Fire Department UTV (Utility Vehicle) Bid and Award Contract

For the Agenda of March 4, 2024

<u>Background</u>. After 20 years of use, the city's Grass Rig for the City's Fire Department has reached the end of its useful life and needs replacement. The Fire Department budgeted the purchase for FY23/24 and recently solicited bids for a new Utility Vehicle/Grass Rig to combat grass fires, wildland fire-fighting, and off-road rescue.

As reflected in the memo (att'd) from Fire Chief Jim Chapman, the city received ten bids. A review of the bid documents submitted has been completed and the Fire Chief's recommendations are outlined within the memo. The recommended bid is technically the second lowest bid (the lowest bid was for equipment that has a smaller engine and is a year older), but due to the reasons outlined in the Fire Chief's memo, I concur with his assessment and am recommending the purchase from Lakeside Motor Sports in Mecosta. Lakeside is also taking our existing rig (20 years old and we paid \$10,795) in on trade and giving us \$6,500 towards the cost of the new UTV.

The City Commission is asked to approve the bids and authorize the expenditure of funds for the purchase of a new UTV, and authorize the City Manager to sign all documents necessary to complete this purchase and authorize the City Treasurer to make any necessary budget amendments related to the purchase.

<u>Issues & Questions Specified</u>. Should the City Commission approve the bids and authorize the expenditure of funds to purchase a new UTV?

#### Alternatives.

- 1. Approve the bids and authorize the expenditure of funds in the amount of the bid offered by Lakeside Motor Sports.
- 2. Approve the bids and authorize the expenditure of funds in an amount commensurate with one of the other bidders.
- 3. Direct the solicitation of new bids.
- 4. Direct this project not be completed.
- 5. Set aside a decision regarding this matter to a subsequently scheduled public meeting.

<u>Financial Impact</u>. The City budgeted \$30,000 for the purchase of new equipment in the approved 2023/2024 CIP fire budget. The bid from Lakeside is \$15,780 with a \$6,500 trade-in, leaving an end cost of \$9,280 from city funds.

<u>Recommendation</u>. I recommend that the City Commission approve the bids, authorize the expenditure of funds for the purchase price of the new UTV at \$15,780 less the equipment trade-in of \$6,500, for a final cost of \$9,280 for the new UTV, and award the bid to Lakeside Motor Sports by the adoption of Resolution 2024-012 (*copy att'd*).



The Kawasaki 1000 Mule has the larger cargo box and the largest seating area and by all means is the best fit for our application. It also comes with a three-year warranty. The dealer is Lakeside Motor Sports in Mecosta. As a bonus they have offered to pay \$6,500.00 for our used 2004 Kubota RTV900. We paid \$10,795.00 twenty years ago. With the trade in, the purchase price of the new unit is \$9,280.00. I have budgeted \$30,000.00 for this purchase.

**WHEREAS**, the City's 2023/2024 approved Capital Improvement Program (CIP) and Budget includes funding for the purchase of a new Utility Vehicle/Grass Rig for the city's Fire Department; and

WHEREAS, the City solicited bids for the replacement of said UTV; and

WHEREAS, the City received ten bids; and

WHEREAS, City Staff have reviewed said bids for compliance with bid specifications and City requirements and has subsequently recommended that the City Commission approve the bids and award the bid to Lakeside Motor Sports of Mecosta; and

**WHEREAS,** the City Commission has reviewed and considered said recommendation and deemed it reasonable, appropriate, prudent, and in the City's best interests.

**NOW THEREFORE BE IT RESOLVED THAT** the Clare City Commission hereby approves the bids submitted and authorizes the purchase of a new UTV for the City's Fire Department from Lakeside Motorsports for the purchase expenditure in the amount of \$15,780 less \$6,500 for the trade in of the Fire Department's current grass rig, for a final cost to the city in the amount of \$9,280.
