<u>Lake Shamrock Dredging and Dam Project.</u> Mechanical dredging by the City is continuing in front of Shamrock Park and we are still making good progress even with the recent winter storms and colder temperatures. For the hydraulic dredging project, Savin has begun dredging with their 2 hydraulic dredges. They will be installing a booster pump as well which will help increase the speed the material is pumped to the holding cell. They hope to continue as long as possible with the weather and ice and if they can they will be running from early morning to late in the evening with the possibility of running a night shift at some point as well. We are working on a letter to send to lake owners to give them an update on the progress and the process soon. The Dam feasibility study work is continuing and there is no new update other than we are continuing to work with them on the preparation of further designs and the full submission of the additional 3 million dollar grant we are applying for now that we have made it past the first round. We also applied for an additional grant funding source that we are waiting to hear back from as well.
