Background. Joy Simmer has completed ten years of faithful, dedicated service to the City of Clare as the Director of the City's Parks and Recreation Department. We ask that the City Commission recognize Joy for her extraordinarily outstanding service.

Issues & Questions Specified. Should the City Commission formally recognize Joy Simmer for 10 years of faithful, dedicated public service?

Alternatives.

3. Set aside the matter for further discussion and consideration at a subsequently scheduled public meeting.

Financial Impact. The fiscal impact to the City is approximately \$50 (\$25 stipend and \$25 for a framed resolution).

Recommendations. I recommend that the City Commission recognize and honor Joy Simmer by adoption of Resolution 2024-057 (*att'd*).
