Background. Historically, the City Commission has set the date and time for Halloween trick-or-treating within the City. Generally, these hours are set for 6:00 p.m. to 8:00 p.m. on October 31st – which falls on Thursday this year. It is being recommended by Recreation Director Joy Simmer that the City Commission set the date for the City of Clare Trick or Treating to Thursday, October 31, 2024, from 6:00 p.m. to 8:00 p.m.
